G.N. 157 ENLARGEMENT OF TIME FOR COMMISSION OF INQUIRY
(Section 3(a) of the Commissions of Inquiry Ordinance)

WHEREAS a Commission of Inquiry was appointed on the 10 day of July, 2008, to inquire into:

Whether there is information that corruption or other serious dishonesty in relation to past and present elected members of the TCI House of Assembly (previously known as the Legislative Council) may have taken place in recent years;

and to submit its preliminary findings and recommendations to the Governor within sixteen weeks of the date of the appointment.

AND WHEREAS section 3(a) of the Commissions of Inquiry Ordinance provides inter alia that the Governor may from time to time enlarge the time within which such inquiry is to be held and the report rendered.

AND WHEREAS in exercise of the powers conferred on me by section 3(a) I, by instruments dated 21st day of October 2008 and 5th February 2009 enlarge the time within which the Commissions was to render its findings and recommendations.

AND WHEREAS the Commission submitted its interim report on 28th February 2009 and it is now necessary for a further enlargement of the time for submission of the Commission's final report.

NOW THEREFORE, I, GORDON WETHERELL, Governor of the Turks and Caicos Islands, in exercise of the powers conferred on me by the said section 3(a) of the Commissions of Inquiry

Ordinance, do hereby direct that the Commission shall submit its final report to me on or before 31st May 2009.
